## **TEXAS OCCUPATIONAL DRIVER'S LICENSE (ODL) PACKET**

- **FULLY READ** all the documents and forms included in this packet. **If you fail to follow these instructions you will have a delay in receiving your ODL Hearing Date**
- Check the status of your Driver's License to make sure you are actually in need of an Occupational Driver's License. See attached sheet entitled Driver License Status Information

**Filing Fees:** \$46.00 or Statement of Inability to Afford Court Costs

**In order to obtain an occupational license:** you must demonstrate an essential need to operate a motor vehicle. The Texas Transportation Code defines "essential need" as the "need of a person for the operation of a motor vehicle: (A) in the performance of an occupation or trade or for transportation to and from the place at which the person practices the person's occupation or trade; (B) for transportation to and from an educational facility in which the person is enrolled; or (C) in the performance of essential household duties." In order to demonstrate an essential need to operate a motor vehicle, you may attach additional documentation, such as a letter from your employer. ) You CANNOT operate a commercial motor vehicle (CMV) with an ODL.

**File:** (3 total copies of the Petition and 3 total copies of all supporting documents) ODL Petition, SR-22, Certified Abstract Driving Record (**Type AR**) and any other supporting documents; the court will draft the Order, you do not need to file one with the court.

- If you have the audit number from your driver's license you can obtain your Type AR driving record on-line. If you **DO NOT** know your driver's license audit number you will have to request your driving record by mail. (see attached form) Please visit for more info.:

- In most cases the clerk of the court will set your case for a hearing within 2 weeks of filing your documents and paying your court cost or Statement of Inability to Afford Payment of Court Costs .
- If filing a Statement of Inability to Afford Court Costs **you must provide supporting documentation** of income, public benefits/government entitlements, legal aid representation or any other supporting documents.
- Make sure you fill out the petition completely and attach all necessary and supporting documents; failure to do so may result in a second hearing being set.
- If you file your case/documents in the wrong court or your Occupational Driver's License is denied you **WILL NOT** receive a refund.
- Please double check all your documents before filing with the court.
- **Make sure you put the times when you need to drive; the hours do not have to be consecutive hours but cannot be more than 12 hours in a 24 hour period (12 am - 11:59 pm).**
- **Please look over the Texas County Map when listing the names of the counties you will be traveling in; You need to include the all counties you will be traveling through, not just the county you start in and the county you end in.**

## **Driver License Status Information AND Driving Record Information**

### 1. **License Eligibility Status**

Check your license eligibility status at <https://txapps.texas.gov/txapp/txdps/dleligibility/login.do>

This free site will tell you if you can drive with your current license and, if not, what you need to do to become eligible. If you are not eligible, the website will assist you in:

- paying fees charges to you for your driver license suspension offenses;
- view compliance items needed to determine and understand your license eligibility; and
- track your driving eligibility status as you go through the process.

You can pay fees on this website and get information on how to mail proof that you met the compliance requirements to DPS. Keep checking the website because it is updated daily.

You can also call the Texas Department of Public Safety (DPS) to check your eligibility/qualifying status at 512-424-2600 (English) and 512-424-7181 (Español)

**Be careful! Recent court actions, out-of-state violations, and AG-reported child support arrearages may not be reflected in your current eligibility status.**

### 2. **OMNIBASE Service - Failure to Appear/Failure to Pay Program**

If you failed to appear in court or failed to pay court cost, fines or any fees owed to the reporting court your driver's license may be denied renewal until the reported violation is cleared. You need to contact the court directly to get this taken care of. Being in the OMNI system is NOT a suspension. Therefore, you CANNOT obtain an ODL in order to avoid paying these fees. If you have a current suspension and are in the OMNI system you can obtain an ODL, but it MAY NOT be valid until you pay the fees owed to the reporting court directly. It will take 3-5 business days to update your driving record from the date the information is reported from the reporting court.

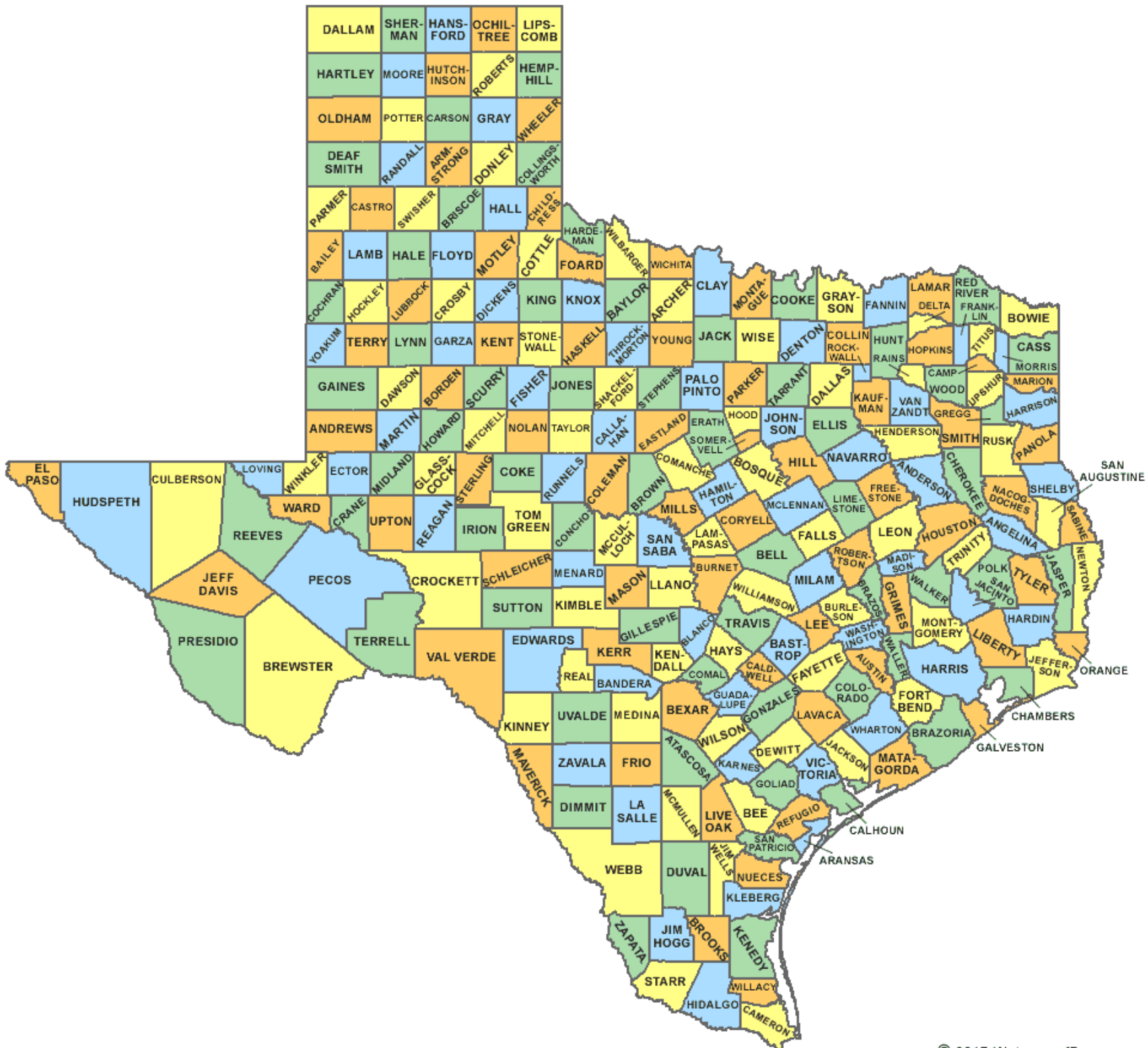

are followed even if you have an attorney\*\*\*\*\***

**• READ THIS CAREFULLY AND IF YOU HAVE ANY QUESTIONS  
YOU CAN ASK THE JUDGE AT YOUR ODL HEARING**

1. Reminder that you CANNOT drive a Commercial Motor Vehicle (CMV) with an ODL.
2. One of the certified copies you receive will serve as your license for 45 days. After the 45 days you will have to have the certified copy of the order **and** the ODL issued by DPS.
3. The second certified copy you receive from this court will need to be sent the Texas DPS along with **\$10 for a 1 year license/\$20 for a 2 year license:**

4. DPS will grant your ODL when it becomes effective, usually immediately; see last page of order for effective date.
5. You may also have a reinstatement fee that is due to the State; look on the first page of your driving record under Status Information and Administrative Status to see if a reinstatement fee is due in your situation; you can also look at the website listed below:

6. If you fail to operate a motor vehicle in violation of the restrictions imposed in this ODL or you fail to have your certified copy of the court's order while you are operating a motor vehicle you can be charged with a Class B Misdemeanor; If you are convicted of one of these the court shall issue an order revoking this ODL; ODL can be revoked anytime for good cause.
7. If you operate a motor vehicle and fail to comply with one of the additional conditions listed on page 2 of this order your ODL will be revoked by this court.
8. If you need to modify this ODL, and it is otherwise still a valid order, please file a written request with our court listing the cause number at the top of the order, your name, the reason for the modification and what you need modified in the order. No filing fee is required for a modification. A hearing will be set and a modified order will be issued if the judge approves the modifications.
