REQUEST FOR RELEASE OF FUNDS

On or about December 6, 2024 San Patricio County (County) will submit a request to the Texas General Land Office (GLO) for the release of Community Development Block Grant Mitigation funding (CDBG-MIT) appropriated under the Supplemental Appropriations for Disaster Relief Requirements Act, 2018 (Pub. L. 115-123), as amended, to undertake a project known as Flood & Drainage Improvements to mitigate flooding by improving the conveyance of stormwater, under GLO Contract #24-085-011-D239.

<u>Project Description</u>: Subrecipient shall deepen and widen existing outfall channels and ditches, reconstruct bridges and trestle, harden ditch stretches that are subject to erosion, and complete associated appurtenances.

FINAL NOTICE AND PUBLIC EXPLANATION OF A PROPOSED ACTIVITY IN A FEDERAL FLOOD RISK MANAGEMENT STANDARD DESIGNATED FLOODPLAIN AND WETLAND

This is to give notice that the County has, under 24 CFR Part 58, conducted an evaluation as required by Executive Order 11988 and 11990, as amended by Executive Order 13690, in accordance with HUD regulations at 24 CFR 55.20 Subpart C, Procedures for Making Determinations on Floodplain Management and Wetlands Protection. The project is partially located in the Federal Flood Risk Management Standard (FFRMS) floodplain and also a Riverine Wetland. The extent of the FFRMS floodplain and wetland was determined using the Freeboard Value Approach. Approximately 82-acres of project activities are in the FFRMS Floodplain and Wetland in Sinton, and approximately 17-acres in Taft. Work in the wetlands will be approached under the appropriate Nationwide or Individual Permit, which will be identified at the conclusion of delineation efforts. The permit will be obtained prior to construction. All limits and conditions of the permit will be followed. There will be no adverse effects on the floodplain or wetland because the drainage channel improvements will improve the conveyance of stormwater, reducing flooding and topography changes. HUD's 8-Step decision-making process of §55.20 to comply with 24 CFR Part 55 was completed.

The County has considered the following alternatives and mitigation measures to minimize adverse impacts and to restore and preserve natural and beneficial functions and intrinsic values of the existing floodplain and wetland: (A) The original plan was to continue the channel widening all the way to near TX-188. After a hydrologic and hydraulic study, the Taft scope was reduced to end before the railroad trestle as that would produce the best results to mitigate flooding in the nearby community. (B) Taking no action would incur no costs for the project and would cause no construction-related environmental impact but would be unable to address the problem of flooding from the poor conveyance of storm water.

The County has reevaluated alternatives to building in the floodplain and wetland and has determined that it has no practicable alternative to floodplain and wetland development. Environmental files documenting compliance with Executive Order 11988 and 11990, as amended by Executive Order 13690, are available for public inspection, review and copying as outlined in the paragraph of FINDING OF NO SIGNIFICANT IMPACT.

There are three primary purposes for this notice. First, people who may be affected by activities in a floodplain and wetland and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplains and wetlands can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains and wetlands, it must inform those who may be put at greater or continued risk.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments/objections on the ERR to San Patricio County. Written comments received by December 5, 2024 will be considered by the County prior to authorizing submission of a request for release of funds. Comments must be prepared and submitted via email in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the County at mcooper@sanpatriciocountytx.gov or by mail to: San Patricio County, 1301 East Sinton Street, Suite C, Sinton, TX 78387, Attn: Mayor's Office. ENVIRONMENTAL CERTIFICATION

San Patricio County certifies to the Texas General Land Office that David R. Krebs, in his capacity as County Judge, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. GLO's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows San Patricio County to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

GLO will accept objections to its release of funds and San Patricio County's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the County; (b) the County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by GLO (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Heather Lagrone, Texas General Land Office, Community Development and Revitalization, P.O.
