A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MATHIS, ORDERING A GENERAL ELECTION AND ESTABLISHING PROCEDURES FOR SAID ELECTION TO BE HELD ON SATURDAY, MAY 2, 2026; THE GENERAL ELECTION SHALL BE FOR THE PURPOSE OF ELECTING CITY COUNCIL MEMBERS TO THREE (3) PLACES FOR A TWO (2) YEAR TERM; AND AUTHORIZING THE GIVING OF NOTICE OF SUCH ELECTION.

NOW THEREFORE; BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MATHIS, TEXAS THAT;

In accordance with the general laws and Constitution of the State of Texas, and the Charter of the City, a General Election is hereby called and ordered for Saturday, May 2, 2026. All residents, qualified voters, of the City of Mathis shall be permitted to vote in said election for the purpose of electing:

Council Member Place 1
Council Member Place 2
Council Member Place 4

SECTION 1. Applications to have the name of a candidate placed on the ballot may not be filed earlier than thirty (30) days before the deadline prescribed by the Election Code for filing applications with the City Secretary, and that the earliest date for a candidate to file same will be Wednesday, January 14, 2026, at 8:00 a.m., with the last day for filing to be Friday, February 13, 2026, at 5:00 p.m., in accordance with Election Code Sec. 143.006 and 143.007.

SECTION 2. The City of Mathis has contracted for election services with San Patricio County for the May 2, 2026 Election. The San Patricio County Election Administrator, Victoria Pereida, is hereby appointed the Early Voting Clerk.

SECTION 3. The election and early voting shall be conducted at the time and in the manner specified in an agreement between San Patricio County and the City of Mathis regarding election process and practices.

SECTION 4. The polling place for the election-on-Election Day shall be open from 7:00 a.m. until 7:00 p.m., Saturday, May 2, 2026 at the following location:

SECTION 5. Early voting by personal appearance will be conducted each weekday at the Mathis City Hall Annex as follows:

Monday, April 20, 2026	7:00 a.m. – 7:00 p.m.
Wednesday, April 22, 2026	8:00 a.m. – 5:00 p.m.
Thursday, April 23, 2026	8:00 a.m. – 5:00 p.m.
Friday, April 24, 2026	8:00 a.m. – 5:00 p.m.
Monday, April 27, 2026	7:00 a.m. – 7:00 p.m.
Tuesday, April 28, 2026	8:00 a.m. – 5:00 p.m.

SECTION 6. The Presiding Election Judge, Alternate Presiding Judge and election clerks shall be appointed by the San Patricio County Election Administrator.

SECTION 7. All applications for a ballot by mail shall be mailed to:



The Hart Verity Voting System shall be used for the conduct of the Election on election day and for early voting; to be conducted by the San Patricio County Election Administration Office and said system approved by the Texas Secretary of State.

SECTION 9. The City Secretary is hereby authorized and directed to publish and/or post, in the time and manner prescribed by law, all notices required to be so published and/or posted in connection with the conduct of the election.
